HOW TO PREPARE FOR A PAVEMENT ANT TREATMENT

People and pets need to vacate for four (4) hours after chemical treatment is completed

PRIOR TO TREATMENT - INTERIOR:

- □ Clean all areas of the kitchen
 - Cleaning these areas is essential to a successful treatment. The goal of cleaning these areas is to eliminate any crumbs, grease and food particles that may have accumulated.
- □ Pull out the fridge and stove (if possible)
- Our technicians will not be permitted to move your large appliances, however behind the fridge and stove are primary hiding locations for ants.
- □ Thoroughly vacuum the unit
 - Vacuuming will eliminate food sources the ants may be coming indoors to find.
 - Key places to focus on are the areas under appliances (e.g. stove, fridge, microwave).
- □ Move items away from walls
 - All items must be moved a minimum of six (6) inches away from walls.
 - All closets/mechanical rooms must have access along the baseboard (area where the wall meets the floor).
 - Heavy furniture and built-in cabinets may be left in place.
- □ Reduce clutter
 - Pavement ants will tend to hide in cluttered areas, especially near sources of heat and moisture.

PRIOR TO TREATMENT - EXTERIOR:

- □ Move all items away from the exterior walls of your residence
 - All items must be moved a minimum of twelve (12) inches away from the walls (e.g. Firewood, lumber, toys, barbecues, patio furniture).
- □ Cut back all vegetation and tree branches
 - Vegetation should be a minimum of eighteen (18) inches away from exterior walls and tree branches should be a minimum of three (3) feet away.
 - Ensure the concrete foundation is exposed with no soil up against the plastic or wood siding.

POST TREATMENT:

- □ Ensure that all food is stored carefully
 - Sealed in Tupperware or pest-proof containers.
- $\hfill\square$ Fix dripping taps or leaking pipes
 - Roof leaks and gaps around windows, doors, or siding may allow exterior moisture to enter the home encouraging ants to enter.
 - Ensure the concrete foundation is exposed with no soil up against the plastic or wood siding.

SAFETY INFORMATION:

□ All people and pets must vacate for a minimum of FOUR (4) HOURS

- People with allergies, respiratory issues, pregnant or nursing women or children under two (2) years must vacate EIGHT (8) to TWELVE (12) HOURS OR OVERNIGHT.
- □ We will be applying:
 - Dragnet (premethrin 0.5% PCP 24175) or Drione Dust (pyrethrins 1.0% PCP 15255) or Greenway (boron 1.35% PCP 30173)
- Please ventilate for ten (10) minutes upon re-entry and avoid touching treated areas for as long as possible

ADDITONAL INFORMATION:

- □ Additional activity after treatment
 - You may experience activity for up to two (2) weeks after the initial treatment. If activity continues into the third week, a follow up treatment may be required.
